SECTION 2: Hazards identification

Not classified as Hazardous according to the Globally Harmonised System of Classification and Labelling of Chemicals (GHS) and Safe Work Australia criteria.

SECTION 3: Composition/information on ingredients

Mixture of ingredients not classified as hazardous.

Ingredients as per the following: beneficial biology, trace minerals, plant stimulants, complex carbohydrates, organic acids, water. non-ionic wetter.

SECTION 4: First aid measures

Following inhalation: Provide fresh air. In case of respiratory tract irritation, consult a physician.

Following skin contact: After contact with skin, take off immediately all contaminated clothing, and wash immediately with plenty of water. If skin irritation occurs: Get medical advice/attention.

Most important symptoms and effects, both acute and delayed:

May cause eye irritation, redness and tearing. Skin contact may cause mild irritation. Inhalation of mist may cause respiratory irritation. May cause gastrointestinal irritation, nausea, diarrhoea and vomiting.
